2009 Terms of Use

Flag Mountain Camp is a private Christian Camp, owned and operated by the Dakota Conference of Seventh-day Adventists. The camp's primary purpose is to provide a natural setting designed to serve the needs of the Dakota Conference, it's members and invited guests.

I. Camp Use: The camp may be used to meet the spiritual and recreational needs of families, church-sponsored groups, and conference sponsored groups.

II. Application: All arrangements for use of the camp must be made through Camp Director Loren Nelson III, Flag Mountain Camp, 15931 Thomson Ln, Bismarck, ND, 58503, Camp Ph: 605.574.2289 (camp only), 701.400.6298 (cell), 701.223.2881 (home).

III. Fees: Although Flag Mountain Camp belongs to the youth and members of the Dakota Conference, fees are necessary to cover maintenance and overhead costs associated with operating a camp facility.

GENERAL REGULATIONS:

1. Persons or groups using the camp must register with the camp host immediately upon arrival and sign check-out upon departure.
2. The Dakota Conference, the Conference Committee, Conference and/or camp staff or volunteers are not responsible for losses or accidents which may occur on camp property, camp vehicles or equipment.
3. Individuals or groups using the camp facilities are expected to keep the grounds, cabins, rooms, restrooms, kitchen, lodge and wash houses clean and orderly at all times and are responsible for all damages other than normal wear.
4. Campfires are permitted in designated areas only. Camp stoves are permitted at camp sites only. Fire building must adhere to state and federal fire building safety codes and danger indexes.
5. Use of the kitchen must comply with posted health department and use codes. Preparation of meat, poultry, fish or seafood is not permitted in the kitchen.
6. Alcoholic beverages, tobacco, illegal drugs, and those under their influence are not permitted on the premises.
7. Management of the environment is the responsibility of the camp in cooperation with state and federal agencies. Visitors may not cut, remove or deface trees or plants.
8. Visitors are requested not to bring pets. Pets are strictly prohibited in buildings and must be leashed while on the grounds. A fine may be imposed for damages by pets or for the irresponsible management of pets. The camp is not responsible for loss or injury to persons or pets.
9. Groups or individuals using the facilities are responsible for written, spoken and posted use guidelines.
10. The application use deposit may be forfeited if check-out and/or camp use guidelines are not met.
11. For the safety of our guests, Flag Mountain Camp reserves the right to refuse service and/or deny admittance to the property.
